

2019 NCAA/CFO NATIONAL RULES TEST

For each of the following select the correct answer. There is only ONE correct choice for each question.

1. Third and ten at the A-20 and A12 drops back to pass. A12 spots a receiver and starts a forward pass with intentional forward movement of the hand. As the arm and hand are moving forward, A12 clearly starts to bring the ball back to his body with firm control of the ball. A12 is then hit by B54, and the ball falls loose and is immediately recovered by B54 at the A-15.
 - a. Incomplete pass, fourth and ten at the A-20.
 - b. This play is not reviewable by Instant Replay.
 - c. Instant Replay can only review if fumble is ruled on the field.
 - d. Fumble, B's ball at the A-15.

2. Runner A44 carries the ball near the sideline, and strides out of bounds. The ball should be spotted:
 - a. At the location of the ball when the runner's foot touches out of bounds.
 - b. At the position of the ball as it crossed the sideline.
 - c. At the location of the ball when the runner's last foot was inbounds.
 - d. At the spot the ball carrier's foot last touched down inbounds.

3. First and goal at the B-5. A12 scrambles out of the pocket and is looking for a receiver in the end zone. A12 is at the B-10 and no one is open and he legally grounds the ball throwing it out of bounds at the goal line. When the pass is released, A55 is standing at the B-1.
 - a. Foul for Ineligible Receiver downfield. A, second and goal at the B-10.
 - b. No foul for Ineligible Receiver downfield.
 - c. Foul for Ineligible Receiver downfield. A, first and goal at the B-10.
 - d. Foul for Ineligible Receiver downfield. A, first and goal at the B-15.

4. Second and 10 at the A-30, A44 runs a sweep and is tackled at the A-33. Defensive back, B21 blocks pulling lineman A77 below the waist at the line of scrimmage. The low block by B21 was not directed from the front.
 - a. A's ball, third and 7 from the A-33.
 - b. A's ball, first and ten at the A-40.
 - c. A's ball, first and ten at the A-48.
 - d. A's ball, first and ten at the A-45.

5. First and 10 at the A-30. A12 is in the pocket and throws an incomplete pass downfield. B55 is flagged for targeting A12, and the Referee's announcement includes Roughing the passer with targeting. After review, the replay official can confirm all aspects of the targeting foul except for the indicator of targeting. Video shows there might or might not be an indicator of targeting by B55.
 - a. Team A's ball, first and 10 at the A-30. B55 is not disqualified.

- b. Team A's ball, first and ten at the A-45 and B55 is disqualified.
 - c. The call of Targeting must stand.
 - d. Team A's ball, first and 10 at the A-45. B55 is not disqualified.
6. First and 10 at the A-20. A12 completes a pass to A88 who is downed at the A-28. Before the next play, Instant Replay reviews the play and sees that B55 takes aim at A12, lowers his head and attacks and initiates forcible contact with the crown of his helmet to the chest of A12.
- a. Second and two at the A-28.
 - b. Replay initiates a review and creates a Targeting foul against B55. Team A's ball, first and 10 at the A-35. B55 is disqualified.
 - c. Replay initiates a review and creates a Targeting foul against B55. Team A's ball, first and 10 at the A-43. B55 is disqualified.
 - d. First and ten at the A-43. B55 is not disqualified.
7. Free safety, B44 is disqualified for targeting during the 4th quarter of his team's 10th scheduled game of the season. The call is confirmed by replay and this is B44's 3rd targeting foul for the season.
- a. B44 is disqualified and must sit out the first half of his team's 11th scheduled game of the season.
 - b. B44 is disqualified and must sit out the first half of his team's 11th scheduled game of the season and then miss the 2nd half of game 11 and the 1st half of game 12.
 - c. B44 may appeal the disqualification to the National Coordinator of Officials.
 - d. B44 is disqualified and is suspended for his team's 11th scheduled game of the season.
8. During a punt return, B21 delivers a blind side block to A30 by attacking his opponent with forcible contact to the chest. The block by B21 was outside the field of vision for A30 and there is no helmet to helmet collision. The punt is returned for a touchdown.
- a. No foul for blind-side block – Touchdown.
 - b. Foul for blind-side block by B21. Fifteen yard penalty from the spot of the foul and B21 is disqualified.
 - c. Foul for blind-side block by B21. Fifteen yard penalty from the spot of the foul. B21 is not disqualified.
 - d. Foul for blind-side block by B21. Fifteen yard penalty from the end of the kick. B21 is not disqualified.
9. During a punt return, B21 delivers a block to A30 by extending his hands and shoving A30 hard into the front of the shoulder. The block by B21 was outside the field of vision for A30. The punt is returned for a touchdown.
- a. No foul for blind-side block – Touchdown.
 - b. Foul for blind-side block by B21. Fifteen yard penalty from the spot of the foul and B21 is disqualified.
 - c. Foul for blind-side block by B21. Fifteen yard penalty from the spot of the foul. B21 is not disqualified.

d. Foul for blind-side block by B21. Fifteen yard penalty from the end of the kick. B21 is not disqualified.

10. During a punt return, B21 delivers a blind side block to A30 by attacking his opponent with forcible contact to the chest and the foul is called on the field. The punt is returned for a touchdown. After video review, it is determined that the force of the block is to the head of A30 and there is a launch by B21.

a. No foul for blind-side block – Touchdown.

b. Foul for blind-side block with targeting by B21. Fifteen yard penalty from the spot of the foul and B21 is disqualified.

c. Foul for blind-side block by B21. Fifteen yard penalty from the spot of the foul. B21 is not disqualified.

d. Foul for blind-side block by B21. Fifteen yard penalty from the end of the kick. B21 is not disqualified.

11. During the opening kick-off from the A-35, B21 and B44 come together and are aligned shoulder to shoulder within 2 yards of each other to block for the ball carrier at the B-16. The kick is caught and returned to the B-26.

a. Team B's ball, first and 10 at the B-8.

b. Team B's ball, first and 10 at the B-13.

c. Team B's ball, first and 10 at the B-26.

d. Team A has the option to re-kick from the 50.

12. During the opening kick-off from the A-35, B21 and B44 come together and are aligned shoulder to shoulder within 2 yards of each other to block for the ball carrier at the B-40. The kick is caught and returned to the B-30.

a. Team B's ball, first and 10 at the B-25.

b. Team B's ball, first and 10 at the B-15.

c. Team B's ball, first and 10 at the B-30.

d. Team A has the option to re-kick from the 50.

13. During the opening kick-off from the A-35, B21 and B44 come together and are aligned shoulder to shoulder within 2 yards of each other to block for the ball carrier at the B-30. Receiver B15 calls for and completes a fair catch at the B-5.

a. Team B's ball, first and 10 at the B-2 ½.

b. Team B's ball, first and 10 at the B-15.

c. Team B's ball, first and 10 at the B-25.

d. Team A has the option to re-kick from the 50.

14. During a second half kick-off from the A-35, B21 and B44 come together and are aligned shoulder to shoulder within 2 yards of each other to block for the ball carrier at the B-30. The kick is caught and returned to the B-40. B44 was guilty of a taunting foul in the first half.

a. Team B's ball, first and 10 at the B-15 and B44 is disqualified for his second Unsportsmanlike conduct foul.

- b. Team B's ball, first and 10 at the B-15.
 - c. Team B's ball, first and 10 at the B-25 and B44 is disqualified for his second Unsportsmanlike conduct foul.
 - d. Team A has the option to re-kick from the 50 and B44 is disqualified for his second Unsportsmanlike conduct foul.
15. During the opening kick-off from the A-35, B21 and B44 come together for a double team block at the B-16 but are never aligned shoulder to shoulder. The kick is caught and returned to the B-26.
- a. Team B's ball, first and 10 at the B-8.
 - b. Team B's ball, first and 10 at the B-13.
 - c. Team B's ball, first and 10 at the B-26.
 - d. Team A has the option to re-kick from the 50.
16. Team A (the Home Team) completes a successful 2 point play to tie the game at the end of the 4th extra period. After the try, A21 begins taunting Team B players while imitating a slashing of the throat. As officials prepare for the 5th extra period, the Visiting team has the 1st choice of options for the 5th extra period.
- a. The foul may not carry over to the 5th extra period.
 - b. If the Visiting team selects defense first, the Home team will begin their possession series from the 40 yard line.
 - c. If the Visiting team selects defense first, the Home team will put the ball in play at the 18 yard line for their one play two point try.
 - d. If the Visiting team selects offense first, they will put the ball in play at the 12 ½ yard line to begin their possession series.
17. Third and five at the B-20 late in the fourth quarter. A11 carries to the B-16 where he is tackled by B79 and injured. When stopped, the clock reads 0:05, and Team A has no time outs remaining. On this play:
- a. There is no option for a 10-second subtraction.
 - b. There is a 10-second subtraction option, but not if A68 also held B53.
 - c. There is a 10-second subtraction option, but not if B79 also lost his helmet.
 - d. Both b and c.
18. Third and five at the B-20 late in the fourth quarter. A11 carries to the B-14 where he is tackled by B79 and injured. When stopped, the clock reads 0:05, and Team A has no time outs remaining. On this play:
- a. There is no option for a 10-second subtraction.
 - b. There is a 10-second subtraction option, but not if A68 also held B53.
 - c. There is a 10-second subtraction option, but not if B79 also lost his helmet.
 - d. Both b and c.
19. Fourth and 10 at the B-45. A3's punt is touched first beyond the neutral zone by A85 at the B-15, but B21 picks up the kick at the B-10 and advances it to the B-20 where he fumbles.

A44 recovers the fumble and carries it across B's goal line. During the kick, B36 holds A17 at the line of scrimmage.

- a. A's ball, first and 10 at the B-35. Clock starts on the Referee's signal.
- b. A's ball, first and 10 at the B-35. Clock starts on the snap.
- c. B's ball, first and 10 at the B-15. Clock starts on the snap.
- d. Six points for A. Penalty declined by rule.

20. Try at the B-3. Team A's place kick is blocked behind the line of scrimmage, but the ball bounces to the B-1 where B66 recovers. B66 returns the ball for a 2-point score. During the return, B44 is flagged for holding. Also during the return, A33 blocks an opponent below the waist directly at the front in the 10-2 region.

- a. No score. The fouls for holding and blocking below the waist offset. Replay the Try from the B-3.
- b. No score. Try is over. If both teams foul during the down and Team B had not fouled before the change of possession, the fouls cancel and the down is not repeated.
- c. Replay the Try at the 16½ yard line after enforcing both penalties.
- d. No foul by A33. Repeat the down after the penalty of half the distance from the B-3.
- e. None of the above.

21. Fourth and 12 at the A-30. Punter A44 receives the ball from the snapper, runs to the A-32, runs back to the A-28, and punts the ball. Receiver B22 makes a fair catch at the B-35.

- a. Foul, illegally kicking the ball. Team A, fourth and 17 at the A-25.
- b. Legal play. Team B's ball, first and 10 at the B-35.
- c. Foul, illegal kick. Team A, fourth and 17 at the A-25.
- d. Foul, illegally kicking the ball. Team B, first and 10 at the A-25.
- e. None of the above.

22. Fourth and 12 at the A-30. Punter A44 receives the ball from the snapper, runs to the A-32, and punts. Receiver B22 makes a fair catch at the B-35.

- a. Foul, illegally kicking the ball. Team A, fourth and 17 at the A-25, or Team B, first and 10 at the B-40.
- b. Legal play. Team B's ball, first and 10 at the B-35.
- c. Foul, illegal kick. Team A, fourth and 17 at the A-25.
- d. Foul, Illegal Kick. Team B, first and 10 at the A-25.
- e. None of the above.

23. Try at the B-3. Team A's place kick is blocked behind the line of scrimmage, but the ball bounces to the B-1 where B66 recovers. B66 returns the ball for a 2-point score. At the snap, B44 was lined up in the neutral zone. During the return, A33 blocks an opponent below the waist directly at the front in the 10-2 region.

- a. No score. The fouls for offside and blocking below the waist offset. Replay the Try from the B-3.
- b. No score. Try is over; when there is a foul by either team after a change of possession all penalties are declined by rule

- c. Replay the Try at the 16½ yard line after enforcing both penalties.
- d. No foul by A33. Repeat the down after enforcing half the distance from the B-3.
- e. None of the above.

24. Second and 20 at the A-30. A12 controls the snap and hands off to A34 who carries it outside the tackle box. Under pressure at the A-25, he throws a pass which lands beyond the neutral zone near the hash mark in an area not occupied by an eligible Team A receiver. When the pass was thrown, A56 was at the A-35.

- a. Only A34 fouled.
- b. Only A56 fouled.
- c. Both A34 and A56 fouled.
- d. Neither A34 nor A56 fouled.

25. Fourth and 10 at the B-45. A3's punt is touched first beyond the neutral zone by A85 at the B-15, but B21 picks up the kick at the B-10 and advances it to the B-20 where he fumbles. B44 recovers the fumble while grounded at the B-25. During the kick, B36 holds A17 at the line of scrimmage.

- a. A's ball, first and 10 at the B-35. Clock starts on the Referee's signal.
- b. A's ball, first and 10 at the B-35. Clock starts on the snap.
- c. B's ball, first and 10 at the B-15. Clock starts on the snap.
- d. B's ball, first and 10 at the B-5. Clock starts on the snap.

26. Team A free kick from the A-35. While the kick is in the air, B33 and B52 meet at the B-18 and stand next to each other shoulder-to-shoulder one yard apart before heading upfield to find an opponent to block. B20 catches the kick at the B-2 and returns the ball to the B-28.

- a. B's ball, first and 10 at the B-14.
- b. B's ball, first and 10 at the B-9.
- c. This Unsportsmanlike Conduct foul counts towards a possible game disqualification for B33 and B52.
- d. Both a and c are true.
- e. Both b and c are true.

27. Fourth and 8 at the A-22. A16 punts the ball and it starts to bounce towards Team B's goal line when A50 bats the ball forward at the B-32. The loose ball crosses the sideline at the B-20.

- a. The 10-yard penalty for illegal batting can be enforced from the spot of the foul.
- b. The 10-yard penalty for illegal batting can be enforced from the A-22 or the B-20.
- c. Team B can elect to decline the penalty for illegal batting and take the ball at the B-32.
- d. Both a and c are true.
- e. Both b and c are true.

28. Fourth and 3 at the B-18. Team A attempts a field goal and the kick is blocked at the line of scrimmage. B58 scoops up the ball at the B-32 and returns it across Team A's goal line. After the blocked kick is recovered, B77 forcibly blocks kicker A31 to the ground at the B-24. A31 had not moved from his kicking position and was obviously out of the play before being blocked by B77.

- a. No foul, touchdown for Team B.
- b. A's ball, first and goal at the B-9, foul for Roughing the Kicker.
- c. B's ball, first and 10 at the B-9, personal foul for Unnecessary Roughness.
- d. B's ball, first and 10 at the B-12, personal foul for Unnecessary Roughness.

29. The visiting team takes the field before kickoff with gray jerseys that include gray numerals outlined in black. The visiting team jerseys are a clearly contrasting color to the home team jerseys and had written agreement before the season with the home team to wear gray jerseys.

- a. Legal jerseys.
- b. Illegal jerseys, charged timeout at the start of each quarter the illegal jerseys are worn.
- c. Illegal jerseys, 15-yard penalty at the succeeding spot following the kickoff for each half the visiting team wears the jerseys.

30. Fourth and 3 from the B-21. Team A is lined up to kick a field goal with holder A23 seven yards behind the snapper. Holder A23 receives the snap and pitches the ball over his shoulder to kicker A19 who is trying to run outside the right tackle. Guard A50 pulls to his right and blocks B41 low at the B-19 with his initial contact directed from the front. A19 is tackled at the B-16.

- a. The play is legal only if A23 lifts his knee off the ground before he pitches the ball.
- b. The block by A50 is legal.
- c. The block by A50 is illegal since the play is run from a scrimmage kick formation.
- d. Both a and c.

31. Free kick from the A-35. B21 signals for a fair catch and catches the ball at the B-3 with one foot in the field of play and one foot out of bounds.

- a. Team B can take the ball at the B-25 since a fair catch was made.
- b. Team B must take the ball at the B-3.
- c. Foul for a free kick out of bounds.

32. Third and 6 at the B-44. A16 scrambles as he is trying to find an open receiver downfield. He finally throws from the B-43 to A81. A81 completes the catch and runs out of bounds at the B-19. The game clock is at 0:31 in the 4th quarter. Team A is out of timeouts.

- a. The foul for an illegal forward pass includes a 10-second runoff.
- b. The foul for an illegal forward pass does not include a 10-second runoff since the pass was caught.

33. Free kick from the A-35. Team A is attempting an onside kick. Kicker A3 places the ball on the ground next to the tee but not touching the tee. A3 kicks a bouncing kick that is recovered by B16 at the A-49.
- Legal kick.
 - Team A has fouled for an illegal kick.
 - Team A has fouled for illegally kicking the ball.
34. Fourth and 4 at the B-15. Team A is lined up to kick a field goal. The kick is blocked at the line of scrimmage. B33 muffs the ball at the B-17 in an attempt to possess it. The loose ball eventually goes out of bounds at the B-12.
- B's ball, first and 10 at the B-12
 - B's ball, first and 10 at the B-15
 - B's ball, first and 10 at the B-20
35. Fourth and 9 at the A-41. B33 catches the kick at the B-4 and his original momentum takes him into his end zone. B33 fumbles the ball from the end zone while trying to avoid a tackle and the loose ball crosses the goal line into the field of play and out of bounds at the B-2. B55 blocked low at the B-10 during B33's run.
- B's ball, first and 10 at the B-1.
 - B's ball, first and 10 at the B-2
 - Safety, Team B free kick from the B-20
36. Fourth and 12 at the B-22. Team A is lined up to kick a field goal. The snap is low and bounces off the ground and into holder A16's hands. A16 gathers the ball and places it down on the ground for a place kick. Kicker A31's rhythm is off and he delays his start forward to make the kick. This allows B11 to arrive at the ball before the kicker. B11 intentionally kicks the ball as it is being held, the ball caroms off A31's shins and goes out of bounds at the B-21.
- A's ball, fourth and 7 at the B-17.
 - A's ball, fourth and 2 at the B-12.
 - A's ball, first and 10 at the B-12.
37. Fourth and 2 at the B-12. Team A is lined up to kick a field goal. The kick is successful. B25 roughed the holder after the kick. Team A is behind 17-20 and time expires in the 4th quarter during the down.
- Team A can only enforce the penalty by cancelling the score and enforcing from the previous spot since there is no succeeding kickoff.
 - Team A can enforce the penalty by cancelling the score and enforcing from the previous spot or enforcing the penalty from the succeeding spot in extra periods.
38. Try at the B-3. Team A must attempt a two-point conversion as it is behind 12-14 with no time in the 4th quarter. A16 completes a pass to A80 in the end zone. B-77 makes forcible contact to A16's knees as the pass is being thrown.

- a. Team A can only enforce the penalty by cancelling the score and enforcing on the Try since there is no succeeding kickoff.
- b. Team A can enforce the penalty by accepting the score and enforcing the penalty from the succeeding spot in extra periods.

39. Second and 1 at the B-31. A14 keeps the ball and runs outside the tackle into the side zone. As he approaches the line of scrimmage, he sees A44 open running down the sideline and he throws the ball from the B-29. The pass to A44 is incomplete. The game clock is at 0:41 in the 2nd quarter.

- a. A 10-second runoff is applicable for an incomplete illegal forward pass.
- b. A 10-second runoff is not applicable since the clock was stopped for A14 gaining a first down.

40. Fourth and 6 at the A-44. Team A lines up 11 players with A2 behind the snapper at the A-34 and with these linemen: A81, A70, A44, A60, A32, A67, A83. Snapper A60 puts his hands on the ball while the remaining linemen are all still in a two-point stance with their hands on their thighs. Team A then shifts so that six linemen are 15 yards to the left of snapper A60, lined up as A81, A70, A44, A32, A67, A83. The ball is snapped to A2 who runs to the right and is tackled at the B-45.

- a. This is an illegal shift since the interior linemen shifted after the snapper put his hands on the ball.
- b. Legal formation at the snap since A44 and A32 remained as interior linemen after the shift.
- c. Illegal formation since A60 is at the end of the line at the snap.
- d. Illegal formation since it is no longer obvious a kick will be made and therefore there is no longer a scrimmage kick formation; Team A does not have five linemen numbered 50-79 at the snap.

41. Fourth and 2 at the B-6. A12 takes the snap, pivots and attempts to hand off to back A32 at the B-10. A32 never completely secures the ball from A12's handoff and it hits the ground but bounces immediately back up into A32's hands at the B-9. A32 runs around the left end for a touchdown.

- a. Touchdown, A Try from the B-3
- b. B's ball, first and 10 at the B-10
- c. B's ball, first and 10 at the B-9

42. Fourth and 9 at the A-31. Team A is in scrimmage kick formation. The snap goes over kicker A30's head. A30 is able to recover the ball after one bounce and begins to run to the right. A30 is able to make a kick with his plant foot on the A-31. The untouched kick comes to rest at the B-37 with no players attempting to secure it.

- a. Legal kick, B's ball, first and 10 at the B-22
- b. Illegal kick, the five yard penalty can be enforced from where the subsequent dead ball belongs to Team B.

- c. Illegal kick, the five yard penalty must be enforced from the previous spot and the down replayed.
 - d. Illegal kick, the ball becomes dead immediately, B's ball, first and 10 at the A-26.
43. First and 10 at the A-45. A16 takes the snap and passes to A33 at the B-48. A33 catches the pass and is tackled at the B-25. Before the pass, tackle A72 legally pushes B99 to the ground at the A-42 and then taunts him while standing over him.
- a. A's ball, first and 10 at the B-40
 - b. A's ball, first and 28 at the A-27
 - c. A's ball, first and 25 at the A-30
44. Fourth and 2 at the A-30. Team A is in scrimmage kick formation. Rugby-style kicker A28 takes the snap and rolls to his right. B30 gets free and starts to pursue A28. A28 needs to take extra steps to create separation from B30 but finally makes a kick that goes out of bounds untouched at the B-28. B30 continues his pursuit of A28 and subsequently after the kick is clearly away forcibly contacts him and puts him on the ground.
- a. Personal foul, unnecessary roughness, A's ball, first and 10 at the A-45
 - b. Personal foul, roughing the kicker, A's ball, first and 10 at the A-45
 - c. No foul, B's ball, first and 10 at the B-28
45. Free kick at the 50. Kicker A3 kicks a high, short kick towards the sideline. The untouched kick bounces out of bounds at the B-22.
- a. Team B has an option to have the ball re-kicked at the A-45.
 - b. Team B has an option to take the ball at the B-20.
 - c. Team B has an option to take the ball at the B-22.
 - d. Team B has an option to take the ball at the B-27.
 - e. All of the above are true.
46. Second and 15 at the A-10. A16 takes that snap and rolls to his right. B55 grabs and pushes receiver A89 to the ground as A16 is looking at him. Finding no other receivers open A16 runs and is tackled at the A-12.
- a. A's ball, first and 10 at the A-22
 - b. A's ball, second and 3 at the A-22
 - c. A's ball, first and 10 at the A-20
 - d. A's ball, second and 5 at the A-20
47. Fourth and 17 at the B-43. A5's punt bounces untouched on the B-3 and breaks the plane of Team B's goal line where A85 bats the ball back into the field of play. B44 muffs the ball on B-2 and A68 recovers on the B-5. The ball did not touch the ground in Team B's end zone. During the kick, B55 committed a holding foul on the B-26.
- a. B's ball, first and 10 at the B-10
 - b. A's ball, fourth and 7 at the B-33
 - c. B's ball, first and 10 at the B-1

d. A's ball, first and 10 at the B-33

48. Free kick at the A-35. B92 is in position to recover A4's free kick on the A-42 when he is blocked above the waist by A87. The ball hits B92's helmet and is recovered by A82 on the A-43.

- a. A's ball, first and 10 at the A-43
- b. B's ball, first and 10 at the A-38
- c. B's ball, first and 10 at the A-27
- d. A's free kick at the A-30
- e. B's ball, first and 10 at the A-43

49. Fourth and 8 at the A-42. A6 punts. A84 illegally touches the ball on B's 38 and recovers the ball on B's 22. During the down, A58 pulled B66 down by the face mask on the B-43. A84 commits a dead ball noncontact foul. Team B wants the ball.

- a. B's ball, first and 10 at the A-47
- b. B's ball, first and 10 at the A-32
- c. B's ball, first and 10 at the A-48

50. Free kick at the A-35. B24 signals for a fair catch, but he misjudges the kick and muffs it into the air at the B-10. B31 subsequently muffs the ball at the B-12 and catches it at the B-14. It will be B's ball, first and 10 at the:

- a. B-10.
- b. B-12.
- c. B-14.
- d. B-25.

 - PSK enforcement from the end of the kick, Team B's ball, first and 10 at the B-2.
100. Fourth and seventeen at the B-20. Team A is lined up to attempt a field goal. Just prior to the snap, B55 runs forward and jumps high over the snapper A60 in an attempt to block the kick. The snap is received by holder A12 who rises and throws a pass toward TE A88 at the B15. The pass is incomplete. B55 toppled over A60 as A12 threw the pass.
- Five-yard penalty for leaping plus automatic first down, Team A's ball, first and ten at the B-15.
 - No kick, therefore no foul for leaping. Team B's ball, first and 10 at the B-20.
 - Ten-yard penalty for leaping, repeat the down Team A's ball, fourth and 7 at the B-10.
 - Personal foul for leaping, Team A's ball, first and goal at the B-10.
